2. Presentation of Proxies

3. Adoption of 2023 AGM Minutes

Resolution (1): The minutes of the 2023 AGM held on 24 May 2023 be signed as a true record of the meeting.

4. President's Report (Hugh Chevrant-Breton)

The President's written report was accepted. Key points include:

- A large number of cultural events were held over the past year.
- The French Film Festival, the major revenue-raising cultural event of the year, yielded an increase in sales of 20.5 per cent in 2024 compared to 2023.
- Major projects in progress are renovation of the bathrooms near the main hall and installation of a new IT operating system.

5. Treasurer's Report (presented on behalf of Mariam Hafiz)

The Treasurer's written report was accepted. Key points include:

- The Alliance recorded a loss of \$36,338 for the year ended 31 December 2023.
- Overall income was \$1.2 million in 2023, with education activities accounting for \$770,000 (65%)
 a lower proportion than in previous years. Increasing the level and proportion of income from education will be a continuing focus in 2024.

Gordon Bull indicated that the financial outcome for 2023 was a good result in view of the challenging circumstances during the year.
